| Citation | 1. These Regulations may be cited as the Veterinary (Fees and Other Charges) Regulations, 2015 and shall come into operation on the 1 st day of July, 2015. |
| Application | 2. These Regulations shall apply to- |
| Cap. 319 | (a) All professionals, paraprofessionals, paraprofessional assistants, meat inspectors, veterinary laboratory technicians and artificial insemination technicians required by law to be registered, enrolled, enlisted and licensed; |
| | (b) veterinary facilities, premises, companies undertaking any form of veterinary practice and livestock training institutes that requires registration and monitoring of professional performances as stipulated under the Act; and |
| | (c) any veterinary profession qualifying examinations. |
| Interpretation
Cap. 319 | 3. In these Regulations unless the content otherwise requires- |
| | “Act” means the Veterinary Act; |
| | “renewal” means a retention of the name in the register, roll, list and licence book after expiry of the |

deadline but before being removed from the register, roll, list and licence;

“re-instatement” means reinstated in the register, roll, list and licence after the cancellation of registration, enrolment, listing or licence;

“retention fee” means the payment made by professionals, paraprofessionals, paraprofessional assistants and veterinary facilities to maintain a name in the register, roll and list, and it shall include payments made by Meat Inspectors, Veterinary Laboratory Technicians and Artificial Insemination Technicians to maintain ones’ name in the license book under these Regulations.

Fees and other charges

4. The Fees and Other charges payable to the Veterinary Council specified in the Schedule to these Regulations shall be effective in the undersigned date.

5. All fees and other charges payable to the Veterinary Council under the Act prior to the coming into force of these Regulations are hereby revoked.
